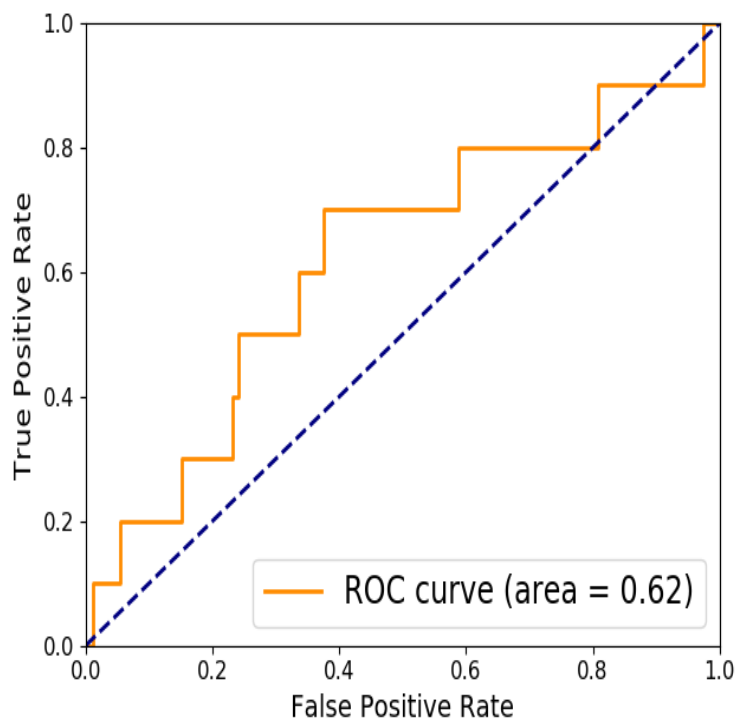
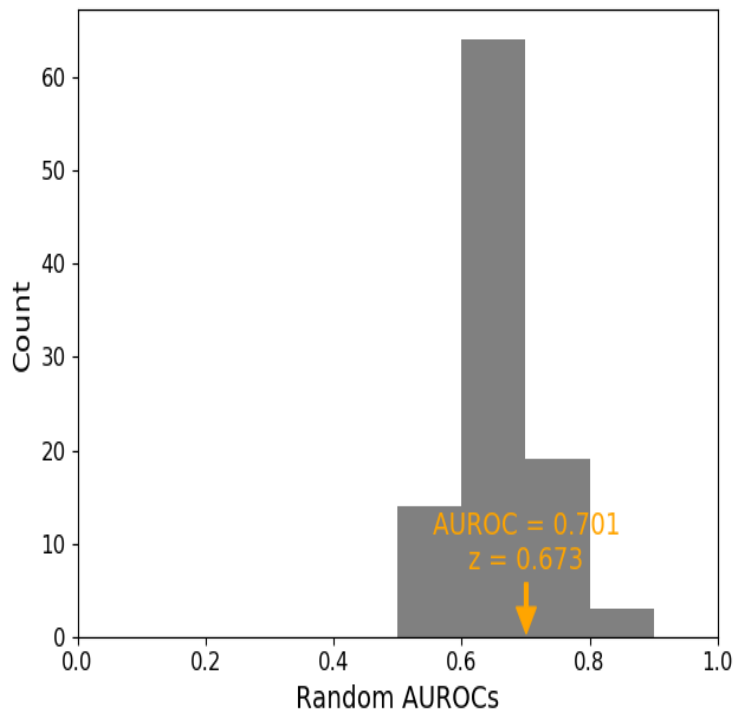


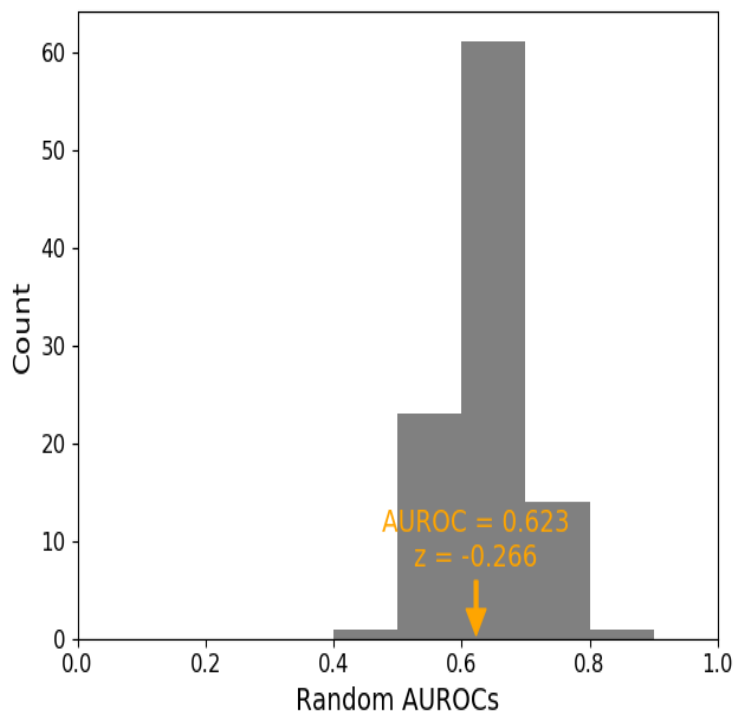
show_1_Diffusion ROC from Gene2axis to Gene1axis STRING10_combined



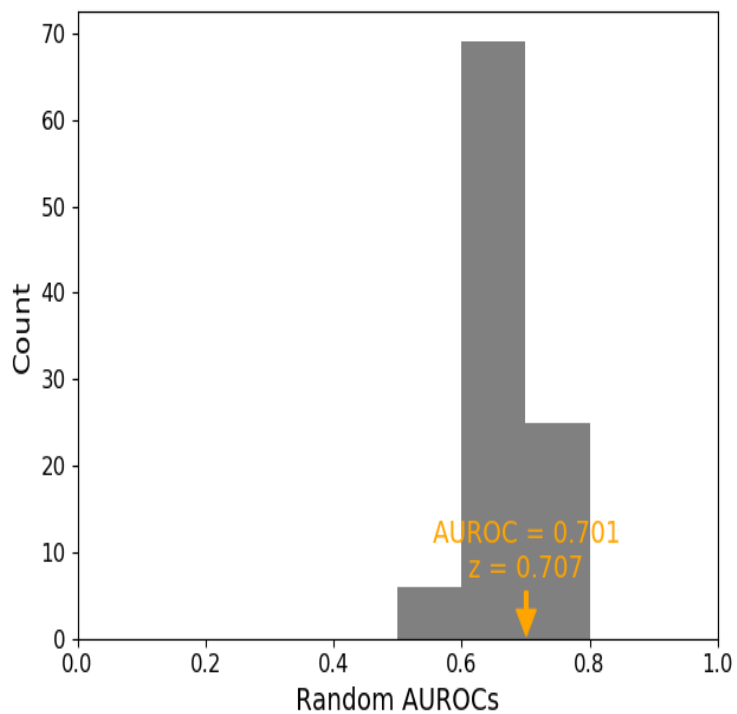

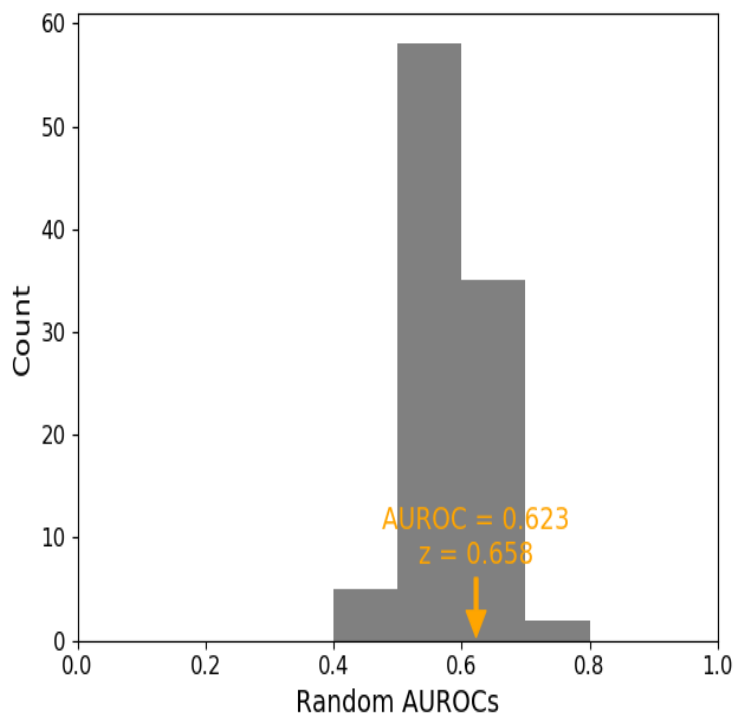

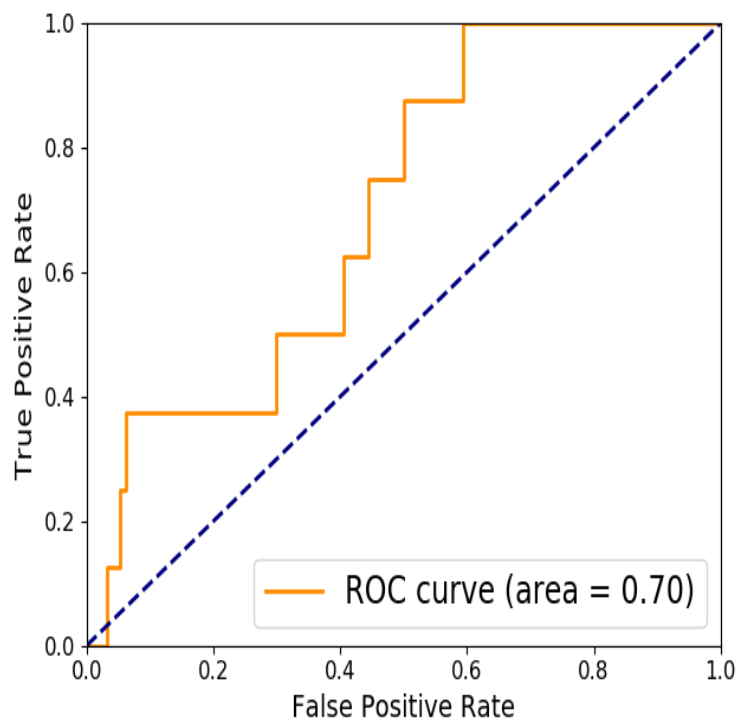
